**ALL CLASSES GOVERNED BY NCSC RULES (PETITE - AMHR GUIDELINES except where superseded by NCSC rules) ALL JUDGES DECISIONS ARE FINAL.**

**ATTIRE** - Proper attire required in all classes-Judge may excuse jackets.  
**CHAMPIONSHIP** - Horse/Rider combination must have been entered and judged in a qualifying class in that division (pleasure &/or eq.) Must have 2 entries to hold class.  
**COGGINS** - Original/Certified Copy of Current Negative Coggins required for horse to be allowed to remain on the grounds. NO EXCEPTIONS!  
**DAY HIGH POINT** - High Point/Reserve High Point ribbons awarded in: O/F 2'-2'3, O/F 2'6-2'9, each Crossrails age division, Western Halter, each LTD age division, Rusty Spur, Rusty Stirrup, Masters, each Open age division, Ranch Horse, Petite Adult & Youth, Petite Halter, Saddle Seat, Gaited, Challenged Assisted Beginner, Challenged Advanced Beginner, Assisted Beginner and Advanced Beginner. There must be at least 2 riders in a division for day end high point to be awarded. Championship class points will be doubled. Ties will be broken by equitation points.  
**ENTRIES** - Show management reserves the right to combine, split or cancel classes.  
**GROUND'S FEE** - \$25/horse - each horse must pay either grounds or stall fee.  
**HEAD GEAR** - Any exhibitor may wear protective head gear without penalty.  
**PAYBACK (\$\$)** - There must be 5 entries in the class in order to receive payback. Payback 1st 30%, 2nd 20%, and 3rd 10% based on \$5.  
**PAYMENT** - Open check or payment in full at sign up. Drivers license required to pay by check. NCSC will close out check if not done so by exhibitor by end of show.

**PRE-ENTRY** - Must be received by 10:00 pm the Tuesday prior to the show. Entries may be done **On-Line:** www.newtoncountysaddleclub.com **Fax/Phone:** 770-385-7383 or **Email:** ncscreentry@yahoo.com. This is the ONLY way you may reserve a stall. There will be NO EXCEPTIONS to the pre-entry deadline. Form must be filled out COMPLETELY. Please reserve RV's sites (\$25/night) in comments section.  
**RAIN** - SHOW WILL BE CONDUCTED RAIN OR SHINE  
**RV SITES** - \$25 per night. Thursday drop off - no hookup/no charge.  
**SCRATCH/ADD CLASSES** - Scratches and add/ons of classes must be accomplished 2 classes prior to the class that is scratched or added enters the arena. This must be done by completing a scratch/add slip at the show office. You will be charged for classes scratched without following this procedure. Please help the gate and also the office keep your account up to date by adhering to these rules!  
**STALLS** - Stalls may be reserved by pre-entry ONLY. Sat night stalls must move in **AFTER** 1pm on Saturday. Requests for stall location will be honored first come/first served. To be stalled together, please help us by pre-entering together.  
**SHAVINGS** - GIHP requires a minimum of 2 bags of shavings per stall. Bring your own shavings or order and pay by credit card through Queen Shavings at 770-860-9111 or 678-416-1424 or at the show grounds at Queen Shavings Building.  
**STALLIONS** - Youth may not handle stallions at NCSC shows - no exceptions.
