



# NEWTON COUNTY SADDLE CLUB RELEASE OF LIABILITY

This agreement releases the Newton County Saddle Club, Inc. and/or their directors, officers, employees, representatives and agents from all liability or claims of every nature relating to any/all risks that may occur while attending the 2024 Newton County Saddle Club Horse Shows. By signing this agreement, I agree, for myself and on behalf of my family, spouse, estate, heirs, executors, administrators, assigns, personal representatives, and any minor over whom I have custody or control or serve as guardian (collectively "I") to hold the Newton County Saddle Club, Inc. and all others listed above entirely free from any liability, including financial responsibility for injuries, sickness, or death incurred, regardless of whether injuries or sickness are caused by negligence or otherwise.

I also acknowledge the risks involved include, but are not limited to, the potential spread of COVID-19 that could result in severe illness or potential death. I am participating voluntarily, and any/all risks have been made clear to me which I fully understand and accept. I will practice proper social distancing as recommended by health department directives, good hygiene (handwashing, hand sanitizer, mask/gloves when required) and follow all other health recommendations ordered or suggested. I do not have any conditions that will increase my likelihood of contracting COVID-19. I also do not have a fever or other symptoms of COVID-19. Should I become ill, whether before or after attendance at either or both shows, I promise to self-report the illness, self-quarantine and will adhere to testing and other illness related guidelines.

By signing below, I forfeit all right to bring a suit or claim against the Newton County Saddle Club, Inc. and/or their directors, officers, employees, representatives and agents for any reason. I will also make every effort to obey safety and health directives.

I hereby enter the above horse(s) at my own risk and agree to release the Newton County Saddle Club, Inc. and the Georgia International Horse Park, its agents, employees and/or any landholder, of any liabilities or responsibilities in case of accident, loss, or injury in any way connected with the show, and agree to indemnify and hold harmless the Newton County Saddle Club, Inc. and the Georgia International Horse Park in the event of any such liability or responsibility to any owner, lessee, trainer, agent, employee, rider/driver, or any other person representing the same in case of accident, loss or injury in any way connected with the show. **WARNING: Under Georgia Law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in activities resulting from the inherent risk of equine activities, pursuant to Chapter 12 of Title 4 of Official Georgia Annotated.
